1. 3. I understand that Circus Activities require physical fitness and abilities, which I may not possess, either due to a medical condition or other reason. Trapeze High has no way of knowing my medical restrictions or my fitness abilities. I hereby certify that I have no medical or physical conditions that could interfere with my ability to safely participate in Circus Arts. I hereby voluntarily assume all risks associated with my participation in Circus Arts, and understand that I am responsible for bearing any costs associated with treating any type of injury that may result from my participation in Circus Arts.

4. Trapeze High reserves the right to take photographs or video of me during my participation in Circus Arts. I expressly permit Trapeze high to use my likeness for marketing activities, including posting on the World Wide Web, and release and forever discharge any rights I or my heirs may have to this media, including but not limited to, receiving any compensation from Trapeze high for use of this media.

BY SIGNING THIS RELEASE, I ACKNOWLEDGE THAT IF ANYONE IS HURT OR PROPERTY IS DAMAGED DURING MY PARTICIPATION IN CIRCUS ARTS, I MAY BE FOUND BY A COURT OF LAW TO HAVE WAIVED MY RIGHT TO MAINTAIN A LAWSUIT AGAINST TRAPEZE HIGH FOR ANY CLAIMS OR DAMAGES.
